End Citizens United, a **grassroots funded** political action committee, is dedicated to countering the disastrous effects of *Citizens United* and reforming our campaign finance system. We are dedicated to returning the power in our Democracy to every day Americans. We're a **traditional PAC**, adhering to contribution limits and full reporting requirements. Funded entirely by small dollar donations since our inception in March 2015, we've **raised almost \$20 million** from **260,000 Americans** giving an **average contribution of \$13**.

This cycle, ECU has:

- Endorsed more than 100 candidates committed to getting Big Money out of politics and overturning *Citizens United*
 - We've supported those candidates by donating \$1 million to candidates; raising more than half a million for candidates; and we will invest about \$15 million in talking to voters to help our endorsed candidates win close races
- Conducted nationwide research and polling on money in politics issues
- Built a grassroots army of more than 1.5 million members who are committed to fighting the special interests that are polluting our system

- Hillary has pledged to push for a constitutional amendment to overturn *Citizens United* within her first 30 days in office.
- She'll appoint judges and Justices who will defend our democracy, not corporate special interests.
- She will call on Congress to pass laws to improve transparency of political spending and will sign an executive order mandating disclosure for federal contractors.

"We can't have secret, unaccountable money poisoning our politics. So I'll appoint Supreme Court justices who will overturn Citizens United and even propose a constitutional amendment to do the same."

- As Attorney General, Catherine fought for Nevadans and stood up to corporate special interests. She supports a constitutional amendment to overturn *Citizens United*.
