	The DISCLOSE Act, introduced in the 114th Congress by Rep. Chris Van Hollen (MD-08), would require that "dark money" groups, such as 501(c)(4) social welfare organizations and 501 (c)(6) chambers of commerce, disclose their donors and spending when they engage in any political activity that mentions a candidate for federal office and/or is intended to influence a federal election.

	The KOCH Act, introduced by Rep. John Yarmuth (KY-03), would require the FCC to demand that outside political groups (dark money organizations) disclose the names of their major donors at the end of political TV ads.
