1.	Do you support or oppose the Supreme Court's <i>Citizens United</i> decision, which allowed corporations to spend unlimited amounts of money on elections?

2.	Do you support the Democracy for All Amendment (H.J. Res. 31), introduced by Rep. Ted Deutch (FL-22), Rep. Jim McGovern (MA-02), and Rep. Jamie Raskin (MD-08)?
	The Democracy for All Amendment is a Constitutional Amendment that would overturn Supreme Court decisions including Citizens United, Buckley v. Valeo, and McCutcheon v. FEC.

	The DISCLOSE Act, introduced by Rep. David Cicilline (RI-01), would require "dark money" groups, such as 501(c)(4) social welfare organizations and 501 (c)(6) organizations, disclose their donors and spending when they engage in any political activity that mentions a candidate for federal office and/or is intended to influence a federal election.

	The Keeping Our Campaigns Honest (KOCH) Act, introduced by Rep. Ben Ray Lujan (NM-03), Rep. Peter Welch (VT-AL) and Rep. John Yarmuth (KY-03), would require the FCC to demand that outside political groups (dark money organizations) disclose the names of their major donors funding political ads.

	The Government By The People Act, introduced by Rep. John Sarbanes (MD-03), would grant voters a voucher worth up to \$50 (through a tax credit) for campaign contributions, and it would provide a six-to-one federal match. This would incentivize candidates to seek widespread small-dollar funding for their campaigns.

I believe super PACs give giant corporations, millionaires and billionaires too much sway in our political system.

The Constitution guarantees political equality, ensuring that every American's voice is heard and valued no matter where they live or how much they make. Yet, the Supreme Court's ruling in Citizens United threatens this key tenant of our democracy by expanding the political influence of corporate special interests and the wealthy. As a member of Congress, I will fight to curtail the influence of dark money in politics and support campaign finance reform measures that ensure transparency and protect the rights of all Americans to an equal voice in government. Money in politics cannot be secret and must be accountable.

Our country needs meaningful campaign finance reform now. I've proposed raising the standards for FEC enforcement and regulation of super PACs; a fee or tax to counter the distortion of politics by special interest money; and, at the state level, modifying filing fees so they are substantially lower for candidates who agree to contribution and spending limits.
