
ECU will use this questionnaire and past votes, statements and actions on campaign finance issues to guide our process for selecting candidates to endorse.

## CANDIDATE QUESTIONNAIRE

**1. Do you support or oppose the Supreme Court's *Citizens United* decision, which allowed corporations to spend unlimited amounts of money on elections?**

**OPPOSE**

**2. Do you support the Democracy for All Amendment (H.J. Res. 31), introduced by Rep. Ted Deutch (FL-22), Rep. Jim McGovern (MA-02), and Rep. Jamie Raskin (MA-08)?** *The Democracy for All Amendment is a Constitutional Amendment that would overturn Supreme Court decisions including Citizens United, Buckley v. Valeo, and McCutcheon v. FEC.*

Note: I recently requested to become a co-sponsor of this amendment.

**3. Do you support the DISCLOSE Act (H.R. 430 in the 114th Congress)?**

*The DISCLOSE Act, introduced in the 114th Congress by Rep. Chris Van Hollen (MD-08), would require that “dark money” groups, such as 501(c)(4) social welfare organizations and 501(c)(6) chambers of commerce, disclose their donors and spending when they engage in any political activity that mentions a candidate for federal office and/or is intended to influence a federal election.*

Note: I am a co-sponsor of this legislation.

**4. Do you support the KOCH Act (H.R. 2125 in the 114th Congress)?**

*The KOCH Act, introduced by Rep. John Yarmuth (KY-03), would require the FCC to demand that outside political groups (dark money organizations) disclose the names of their major donors at the end of political TV ads.*

**5. Do you support the Government By The People Act (H.R. 20 in the 115th Congress)?** *The Government By The People Act, introduced by Rep. John Sarbanes (MD-03), would grant voters a voucher worth up to \$50 (through a tax credit) for campaign contributions, and it would provide a six-to-one federal match. This would incentivize candidates to seek widespread small-dollar funding for their campaigns.*

**6. Do you support the Restoring Integrity to America's Elections Act (H.R. 2931 in the 114th Congress)?**

*The Restoring Integrity to America's Elections Act, introduced by Rep. Derek Kilmer (WA-06) and Rep. Jim Renacci (OH-16), would reform the Federal Elections Committee (FEC) to remove partisan blocks to its ability to function, and would help make it more efficient in addressing campaign finance violations and other developments.*

**NEED MORE INFORMATION**

Note: I recognize that reflexive partisanship and gridlock at the FEC are significant problems. I will gladly commit to seeking solutions, and I agree in concept that introducing decision-makers not affiliated with either party would tend to promote fairer outcomes. However, I would want to familiarize myself more closely with the legislation, and better understand the proposed processes for appointing chairs and commissioners, before making a final commitment.

**7. Do you support the Election Protection & Integrity Certification Act (EPIC Act) (H.R. 5515 in the 114th Congress)?**

*The EPIC Act, introduced by Rep. Derek Kilmer (WA-06) and Rep. Richard Hanna (NY-22), would establish new disclosure requirements for 501(c) organizations to safeguard against the influence of foreign money in American elections.*

**8. Do you oppose the repeal of the Johnson Amendment?** *The Johnson Amendment restricts 501(c)(3) tax-deductible organizations, including churches, from engaging in political activity.*

**9. Do you support legislation requiring that publicly traded companies disclose all political spending to the Securities and Exchange Commission (SEC)?**

*This would increase transparency and hold companies more accountable to their shareholders.*

**10. Under current law, government contractors are restricted from making direct political contributions but are permitted to pass political spending through non-profits, such as 501(c)(4) and 501(c)(6) groups. Do you support legislation to close this loophole?**

**YES**

Note: Obviously my support would depend on the details of the proposed legislation, but I strongly support closure of this loophole and believe effective legislation could be crafted for that purpose.

**11. Please share any additional ways you support meaningful campaign finance reform.**

As I said on last year's questionnaire, I believe that we urgently need to limit the outsized political influence of dark-money groups and very wealthy individuals; to that end, I support strong campaign finance reforms. Overturning *Citizens United* and passing the DISCLOSE Act remain two of the best steps we can take, and I strongly support most of the other ideas put forward in this questionnaire. I have carried campaign finance and disclosure reform legislation at the state level; the list includes a bill to bar lawmakers from fundraising during special legislative sessions, a bill to end taxpayer reimbursement for lawmakers' travel to secret ALEC-type conferences, and a sweeping 2015 bill that would have thoroughly overhauled Virginia's ethics and disclosure laws. I remain committed to building on that work in Congress, and I would expect to support any fair and thoughtful effort to increase transparency in political

spending; eliminate backdoors and workarounds; and otherwise lessen the grip of Koch-like groups on our democracy.
