When we met in September, I shared my thoughts on how to fight back against Citizens United. I agree we need a constitutional amendment, but while that is in the works, I propose addressing the issue through taxation.

If a corporation is recognized as an individual, then a corporation should be taxed as an individual. I think a corporation could have a choice in the matter-since it answers to shareholders. The choice could be:

- a) Exercise your rights as a corporation and file taxes as a corporation
- b) Exercise your rights as an individual and file taxes as an individual

This way, everyone's rights are respected but corporations will have financial choices to make. I'm willing to bet that investors would rather a corporation keep their tax benefits than be subject to individual taxation.

Another way to address through taxation would be to more closely monitor the "primary purpose" of Super PACs. Money used for political purposes should be

subject to tax but frequently goes without.

Addressing the vast sums of dark money in politics is complex, but I believe there are steps we can take now. As someone who has been a tax-paying resident of the 13th for over 2 decades and as the only candidate in this race who has been self-employed for a close to 20 years, I know that individuals and small businesses do not get a break from paying their taxes, and neither should those who are abusing the system that Citizens United has perpetuated. These ideas all require that we elect representatives who are

ready, willing and able to attack the issue head-on and I am the candidate who

will lead this charge in the IL-13th district. I will continue to look for ways to get this money out of politics while we push for a constitutional amendment.
