

Few Supreme Court decisions have had as alarming an effect on our political system as Citizens United v. FEC, which opened the door for a flood of big money special interest groups to swamp our democracy. Our elections should not be for sale to the highest bidder, and in Washington I will fight to overturn this decision and allow states and Congress to effectively regulate campaign spending. We also must do more at the federal level to ensure voters are aware of the sources of funding for the political ads they see, and I would support legislation requiring the public disclosure of ads placed on the internet, just like those on TV or the radio. I've tried to live those values here in Phoenix. During my time as Mayor, I supported an ordinance that imposed harsher penalties on lobbyists that failed to disclose paid lobbying at the city to ensure our regulations had teeth. I will continue to support legislation in Congress that ensures that our government is representative of people, not special interests.
